# 9. Current submitted grant applications

Yaxham Parish Council – Flagpole and Flags

GD had investigated the rules and regulations of flying a flag and informed the Trustees you can fly the Union and County flag at any time.

After a discussion it was felt a 6-metre coated aluminium flagpole with an internal halyard would be desirable along with 3 flags (Norfolk Flag, a Union Flag and a VE Day (Lest we forget) Flag). The total cost of a flagpole, flags and installation would require a grant of £450.00 which was **agreed**.

3Most flag poles are 6 meters. The Chair reported that planning permission may be required if above 4.6 metres. GD would contact Breckland Planning and clarify whether planning permission would be necessary. He would also prepare a risk assessment.

The Chair enquired as to whether the Trustee's felt notices were required informing residents of the wildflower footpaths, saying "No mowing – Bee friendly" or "Wildlife verges". It was felt two signs would be a good idea. PB proposed a budget of £100.00 seconded by GH and **all agreed**. BG agreed to investigate this and report back at the next Parish Council meeting.
